- Improve the physical environment to enable disabled pupils, staff, and visitors to access all areas
 of the school.
- Improve the availability of accessible information to disabled pupils and their families.

Current Context

- **School size**: Small, rural primary school.
- **Strengths**: Warm, inclusive ethos; strong community relationships; staff commitment to individualised support.
- Challenges: Rural location; older buildings with some physical constraints.
