#### Introduction

**School name:** Whittingham C of E Primary School Accessibility Plan (DRAFT)

#### 3-year period covered by the plan:

The School has just become a Primary School in September.

Plan agreed: Initially -February 2016. Finalised July 2016.

Plan Reviewed September 2016. To be reviewed 2019.

Lead member of staff: SEND co-ordinator / Headteacher Belinda Athey.

The SEN and Disability Act 2001 extended the Disability Discrimination Act 1995 (DDA) to cover education. Since September 2002, the Governing Body has had three key duties towards disabled pupils, under Part 4 of the DDA:

- 1. not to treat disabled pupils less favourably for a reason related to their disability;
- 2. to make reasonable adjustments for disabled pupils, so that they are not at a substantial disadvantage;
- 3. to plan to increase access to education for disabled pupils.

This plan sets out the proposals of the Proprietor/Governing Body of the school to increase access to education for disabled pupils in the three areas required by the planning duties in the DDA:

- a) increasing the extent to which disabled pupils can participate in the school curriculum;
- b) improving the environment of the school to increase the extent to which disabled pupils can take advantage of education and associated services;
- c) improving the delivery to disabled pupils of information, which is provided in writing for pupils who are not disabled.

It is a requirement that the school's accessibility plan is resourced, implemented, reviewed and revised as necessary and reported on annually. Attached is a set of action plans showing how the school will address the priorities identified in the plan.

#### The School's Context

We are a small rural Primary School whose one levelbuilding is all on one site and all classrooms lead off the main school hall. There are no separate classroom buildings. During the period of building work each class can be accessed through the main entrance. There is also another exit/ entry point through the Early Years Classroom. In the case of a fire all current entry / exit points will be made safe and the site manager of the building site and the Headteacher will be responsible for the safe exit of children to the allocated fire safety collection point.

We have recently enhanced our school site with our new extension. We also use specialist sport provision at Willowburn Sports Centre and Whittingham Memorial Hall where applicable.
